Roles and Functions of the Internal Complaints Committee (ICC):

- 1. **Receiving Complaints**: The ICC is responsible for receiving complaints of sexual harassment from students, faculty, staff, or any other person associated with the college.
- 2. **Inquiry and Investigation**: The ICC is tasked with conducting a fair and impartial inquiry into the complaints received. This includes gathering evidence, interviewing witnesses, and ensuring confidentiality throughout the process.
- 3. Mediation and Conciliation: The ICC may attempt mediation and conciliation between the complainant and the respondent provided both parties consent to such a process.
- 4. **Decision-Making**: The ICC is responsible for determining whether an incident of sexual harassment has occurred based on the evidence and testimonies presented during the inquiry.
- 5. **Redressal**: If the ICC finds the respondent guilty of sexual harassment, it recommends appropriate disciplinary action to the college administration.
- 6. Awareness and Prevention: The ICC promotes awareness about sexual harassment, prevention strategies, and the rights of individuals within the college community. It may conduct workshops, seminars, or awareness campaigns.
- 7. **Reporting**: The ICC prepares an annual report detailing the number of complaints received, actions taken, and recommendations made. This report is submitted to the college administration and may be shared with relevant authorities.
