
Purpose: The purpose of this MoU is to establish a collaborative framework for mutual cooperation and engagement in various educational and community-oriented initiatives.

5. **Technology Support:** The CSC will provide technical support and guidance to St. Xavier's College in adopting digital tools and technologies for enhancing the educational experience.


6. **Duration:** This MoU shall be in effect for a period of 5 years, starting from the effective date of signing.


